#### **MEMBERSHIPS:**

Annual: Open to descendants age 18 or older. Annual dues (\$70), which are not tax deductible, are paid each year with the

current year's dues payable once Plymouth approves the application.

Junior: For all descendants under age 18, there is a one-time membership fee, which is not tax-deductible, in the amount of

\$50. Members under age 18 do not receive regular Society mailings until they reach 18. They may receive

educational mailings designed for their age group from time to time.

APPLICATION FEE, METHODS AND REFUND POLICY: All applicants must pay an application fee of \$199, which is non-refundable should GSMD reject the line. After submitting the Preliminary Application a fee of \$100 is due before research begins. After required documentation is submitted to the Historian, the balance of the application fee is due before application is submitted to GSMD for approval. The South Carolina annual dues of \$70.00 are due upon approval.

There is NO PAYMENT REQUIRED at this time. Once we have determined the line is viable, \$100 will be due prior to the Historian doing additional work. The \$99 Balance is due when the application is submitted to GSMD.

Please do not hesitate to contact historians with any questions.

Please Note: The GSMD now requires full documentation for all of the last three generations (yourself, your parents and your grandparents) including the spouses as well as the line carriers. Specifically, this means that the General Society requires all marriages and divorces for both line carriers and spouses on those three generations.
