### MEMBERSHIPS:

- Annual:** Open to descendants age 18 or older. Annual dues (\$70), which are not tax-deductible, are paid each year with the first year's dues payable once Plymouth approves the application.
- Junior:** For all descendants under age 18. This is a one-time membership fee, which is not tax-deductible, in the amount of \$50. Members under age 18 do not receive regular Society mailings until they reach 18. They may receive educational mailings designed for their age group from time to time.

**APPLICATION FEE, METHODS AND REFUND POLICY:** SMD-SC has two classifications for Supplemental Applications. A 'Silver Supplemental Application' is one that ties into a Silver book and requires no new documents to support it. A 'Regular Supplement' is one which requires additional documentation to support it than what we already have on file for the applicant. The Silver Supplemental application fee is \$159 each and a Regular Supplemental is \$179, of which half is due when lineage has been determined to be viable. The balance of the Supplemental fee must accompany the application when it is ready to be submitted to GSMD for approval.

There is NO PAYMENT REQUIRED at this time.

Once we have determined the line is viable, half will be due prior to the Historian doing additional work. The balance is due when the application is submitted to GSMD.

Please do not hesitate to contact historians with any questions.

Please Note: The GSMD now requires full documentation for all of the last three generations (yourself, your parents and your grandparents) including the spouses as well as the line carriers. Specifically, this means that the General Society requires all marriages and divorces for both line carriers and spouses on those three generations.
